

DEQ's Drinking Water Protection Advisory Committee Members

The "Source Water Assessment Plan" (or SWAP) was completed in 1999 and described Oregon's methods for completing the source water assessment requirements of the 1996 Amendments to the Safe Drinking Water Act. This document was prepared with the assistance of a citizen and technical drinking water protection advisory committee. This advisory committee

- held meetings to coordinate assessment activities between DHS and DEQ,
- provided recommendations for public involvement in the SWAP process,
- prioritized water systems for source water assessment,
- advised on approach for delineation and susceptibility analyses,
- identified potential sources of contamination and their relative risk levels, and
- advised on SWAP report design and how information is provided to public.
